1. Introduction

Nucleus Advisory Sdn Bhd ("Company," "we," "us," or "our") is committed to protecting your privacy and personal data. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our website and digital self-assessment services.

2. Information We Collect

During the assessment process, we collect:

2.3 Automatically Collected Information

When you visit our website, we automatically collect:

- IP address
- Browser type and version
- Device information
- Operating system
- Pages visited and time spent
- Referring website
- Cookies and similar tracking technologies

3. How We Use Your Information

We use your personal information for the following purposes:

1. Service Delivery: To provide, maintain, and improve our assessment services
1. Assessment Processing: To analyze assessment responses and generate professional reports
1. Consultation: To schedule and conduct personalized consultation sessions
1. Communication: To send order confirmations, assessment instructions, and service updates
1. Customer Support: To respond to inquiries and resolve technical issues
1. Payment Processing: To process transactions and send receipts
1. Legal Compliance: To comply with applicable laws and regulations
1. Service Improvement: To analyze usage patterns and enhance our offerings

1. Security: To detect and prevent fraud and unauthorized access

4. Legal Basis for Processing

Under the Personal Data Protection Act 2010 (Malaysia) and GDPR, we process your personal data based on:

- Contractual Necessity: Processing is necessary to fulfill our contract with you
- Consent: You have provided explicit consent for specific processing activities
- Legitimate Interests: Processing is necessary for our legitimate business interests
- Legal Obligation: Processing is required to comply with legal requirements

5. Data Sharing and Disclosure

We do not sell your personal information. We may share your data with:

5.1 Service Providers

- Payment processors (for secure transaction handling)
- Cloud hosting providers (for data storage)
- Email service providers (for communication delivery)
- Video conferencing platforms (for consultation sessions)

5.2 Legal Requirements

We may disclose your information if required by:

- Court order or legal process
- Government authorities with proper jurisdiction
- Applicable laws and regulations

5.3 Business Transfers

In the event of a merger, acquisition, or sale of assets, your information may be transferred to the acquiring entity.

6. Data Security

We implement appropriate technical and organizational measures to protect your personal data:

7. Data Retention

We retain your personal information for:

- Active Accounts: As long as necessary to provide our services
- Assessment Data: 1 years from the date of assessment (for professional reference)
- Financial Records: 7 years as required by Malaysian tax laws
- Marketing Communications: Until you opt out or withdraw consent

After the retention period, your data will be securely deleted or anonymized.

8. Your Data Protection Rights

Under Malaysian PDPA and GDPR, you have the following rights:

- Right to Access: Request a copy of your personal data
- Right to Rectification: Correct inaccurate or incomplete data
- Right to Erasure: Request deletion of your personal data (subject to legal obligations)
- Right to Restrict Processing: Limit how we use your data
- Right to Data Portability: Receive your data in a structured format
- Right to Object: Object to certain processing activities
- Right to Withdraw Consent: Withdraw consent at any time
